












Most Worshipful Dudley Ridge Smith was born and raised in Yukon, Oklahoma, where he attended elementary and secondary school. He was graduated in 1963 and is currently living on the farm on which he was born.

He joined the U.S. Army in 1966 and served two combat tours in Vietnam: one as a paratrooper and one as a helicopter pilot. Wounded in action while flying a rescue mission near the Cambodian border, he was awarded the Air Medal

with "V" device and two oak leaf clusters, the Purple Heart and other service medals. M W Brother Smith served one tour in Germany, and retired from the Army in 1980 as a Captain.



M W Brother Smith was employed by the Federal Aviation Administration as a Forensic Chemist, Toxicology Laboratory, 1998-2001; and Instructional Systems Designer, Aerospace Medical Education Division, 2001-2008. He retired from the FAA in 2008.

He holds a Bachelors degree in Chemistry from Cameron University, (1977); a Masters Degree in School Administration, Summa Cum Laude, from Central State University, (1985); and a Masters Degree in Instructional Technology from University of Oklahoma, (1995).

He and his wife, Carol, have been married for 46 years. They have two children: a daughter, Dr. Valerie Hatley of Yukon; and a son, Brother Brian Smith of Austin, Texas. His son-in-law is Brother Edward G. Hatley III of Yukon. He has one granddaughter Kira, and three grandsons: Joseph Hatley, Thomas Hatley and Noah Hatley.

Grand Master Smith was raised in Yukon Lodge #90 in 1986. He has served that Lodge in every chair except Chaplain and Tyler, serving as Worshipful Master in 1992. Presently, he serves as Treasurer. He is also a member of El Reno Lodge #50, Mustang Lodge #407, and India Lodge #551

He is a Member of Guthrie Scottish Rite, was Invested Knight Commander of the Court of Honor in 2005; and Coroneted Inspector General Honorary in 2015. He serves as Director of the 23rd Degree Team. M W Brother Smith is a member of Capitol Hill Chapter, Council and

Commandery, York Rite; a member of India Shrine Temple A.A.O.N.M.S; Past President and current member of India Shrine Masonic Degree Team; a member of National Sojourners, Tinker Chapter, and a member of Tall Cedars of Lebanon. He is also a member of Oklahoma Lodge of Research, The Royal Order of Scotland, Oklahoma College, M.S.R.I.C.F., and a member of The Order of the Sacred White Buffalo.

He also belongs to the American Legion, Veterans of Foreign Wars, Disabled American Veterans, Vietnam Helicopter Pilots Association and the Mensa Society.

He is a member of Yukon Order of the Eastern Star Chapter #245 and has



served as Worthy Patron eight times. He served as Worthy Grand Patron of the Grand Chapter of Oklahoma, 2008-2009 and as a General Grand Chapter Committee Member, 2012-2015.

He was State Rainbow Dad, 2002-2003. Rainbow Dad of Yukon Rainbow Assembly #111, various years from 1988 to 2008. He is currently on Advisory Board of Yukon Rainbow Assembly #111; was Chapter Dad of Yukon DeMolay Chapter 1989 to 1995, and is currently Treasurer of Advisory Board of Excalibur Chapter, Order of DeMolay. He was awarded Rainbow Grand Cross of Color and DeMolay Zerubbabel Key, DeMolay Advisor's Honor Key (2), Honorary Legion of Honor, and DeMolay Cross of Honor.

The Grand Master has been an "A" Certificate Lecturer since 1989 and was awarded a Lifetime "A" Certificate in 2014.



From the Grand Master

Brethren.

As we begin a new Masonic year, I want to point out some of the programs which will be available from your Grand Lodge.

First, a new program being implemented this year is the Perpetual Path Program (PPP). This program will enable Entered Apprentices and Fellowcrafts to become Master Masons in one day. The program will be conducted at local Lodges with three to fifteen Brothers being passed and raised in a single day. The PPP program will be conducted on a Saturday since it will require most of the day to do both degrees and the educational program which will give the Brothers additional instruction about the meaning of their degrees.

Two features of this program are: 1) the Brothers going through this program will be required to purchase a perpetual membership in their Lodge at least ten days before the event, and 2) the Brothers will still have to pass their Master Masons proficiency to hold office in their Lodge or to join any of the Concordant or Androgynous bodies without waiting the required six months. I want to emphasize that the traditional method of receiving the degrees is still the best and preferred way, but the PPP program will benefit those Brothers who wish to quickly progress to the degree of Master Mason and who will purchase a perpetual membership in their Lodge. It will also benefit those Brothers who, for one reason or another, have not advanced beyond the EA or Fellowcraft degree in past years. Information about the application process to attend or host one of these events will be mailed to each Lodge.

Another new program which will be implemented this year is the Regional Explanatory Lecture program. It is a constitutional requirement that all Entered Apprentices receive the Entered Apprentice Explanatory Lecture (slides) within sixty days of their initiation and all Master Masons must receive their Master Masons Explanatory Lecture (slides) within sixty days of their raising. This requirement has not always been completed in some Lodges, so we are going to provide several opportunities for Brothers who have not received these lectures to do so. During this year, on months which have a fifth Wednesday, the Deputy Grand Lecturers and other proficient ritualists will present the EA and MM Explanatory Lectures at selected locations around the state. Brothers who have not had the opportunity to receive these lectures, or those who want to see them again, are encouraged to attend these presentations. The first of these presentations will be done on March 30, 2015. More information about times and locations will be disseminated to the Lodges.

Another new program will be a state-wide blood donation drive conducted in partnership with the Oklahoma Blood Institute. Fifteen selected Lodges will host a blood donation drive on January 18, 2016. This is a significant opportunity for the Masons of Oklahoma to help the Oklahoma Blood Institute to provide badly need blood for those who need blood transfusions. The winter is a slow period for blood donations and we hope this state-wide blood drive will help OBI to replenish their supplies. There will be an advertising campaign conducted by OBI to endeavor to increase participation. All Masons who are eligible to donate blood are encouraged to do so.

As well as these new programs, I encourage Lodges to participate in the existing programs which will be continued this year. I highly encourage Lodges to participate in the Award of Excellence program which M W Beisly reinstituted last year. This is an excellent program for Lodges to be recognized for their positive activity. The application for the Award of Excellence is available from Grand Lodge and participation will help each Lodge to grow and improve in Masonry.

I want to mention that the Grand Lodge programs from last year will be continued: Mr. Mason, Medal of Honor, Prevent Blindness, CHIPS, Student of Today, Matching Funds, Student Essay Contest, White Buffalo, Leadership Workshop and all the rest. Every Lodge will have ample opportunities to grow and prosper during 2016.


Our Masonic Family Cookbook is progressing, not quite as fast as I had hoped. The cookbook will be on a disc as well as printed form.

Resolutions which passed and are now Oklahoma Masonic Law

Resolution #2 and Resolution #5 passed.

Until now, when a Lodge received a petition at least 28 days had to pass before the Lodge could vote on the petition. Now, the petition must lay over at least until the next stated meeting, with no required minimum number of days. (Resolution #2)

Until now, Lodge Secretaries were required to file a report of Lodge activity with the Grand Secretary each month whether or not there had been any reportable activity. Now a report must be filed for a month only if there is activity to report.

Otherwise, the report is filed quarterly. (Resolution #5) "Activity" includes such things as Degrees, votes on proficiency, petitions received, suspensions, deaths, etc.

The Oklahoma Masonic Medal of Honor—the highest honor bestowed by the Grand Lodge—was presented to Jesse Dan Swift, Jackie Lynn Painter, and Carl Minor Shelton



Also at Grand Lodge Jim Tresner was elected an Honorary Past Grand Master of the Grand Lodge of the State of Oklahoma.

Frand Master's Frograms for 2016

The Perpetual Path Program

This program allows local Lodges to hold conferrals of the Fellowcraft and Master Mason Degrees on 3 to 15 candidates on a single day. The Grand Lodge will provide educational materials and assist with coordination, but the program is Craft-driven. Candidates wishing to participate in the program must purchase a Perpetual Membership in their Lodge. Full details will be mailed to the Lodges shortly.

The explanatory lectures of the Degrees are just that—explanatory. They explain, flesh-out, and clarify the Degrees, and are where many of the Masonic symbols are presented and given at least a surface explication. They are very important and our law provides they must be given. But, as we all know, usually when a Degree ends the Worshipful Master says, "Now Brother, there is a lecture which follows here. But it's getting late (or "the Brother who usually gives the Lecture isn't here tonight"), and so we'll provide the lecture at another time."

But that time never comes. I know of men who have been Master Masons for more than 10 years and have never heard the Lectures. That's like a BLT sandwich that's missing the bacon.

That is the reason for the Ritual Fulfillment Program. With the help of R W Ronald Wray, Grand Lecturer, we are scheduling a series of special evenings across Oklahoma to which you can bring members who have never received the Lectures (or those who would like to hear them again). A list of locations and dates is being sent to the Lodges and will be posted on the Grand Lodge website.

Oklahoma Blood Institute

We will have a state-wide **blood donation drive** conducted in partnership with the Oklahoma Blood Institute. Fifteen selected Lodges will host a blood donation drive on January 18, 2016. The Grand Lodge of Oklahoma will conduct a Leadership Workshop on June 10-11 at the India Shrine Center, 3601 NW 36th St., Oklahoma City, OK. This is not just for Lodge Wardens and Secretaries, but for every Mason who wants to learn more about being a leader in his Lodge. There will be a special guest speaker from Texas. Cost is projected to be \$125 which will cover the cost of all meals, handouts, and a new Constitution and Code book.

From the Deputy Grand Master

In picking a subject for this article, I wanted to write about something both timely and beneficial to our Fraternity. My thoughts led me to reflect upon the Trowel. It is a very simple tool with no moving parts, just a handle and a blade. Our ritual teaches us: "The Trowel is an instrument made use of by operative masons to spread the cement which unites a building into one common mass, but we as Free and Accepted Masons are taught to make use of it for the more noble and glorious purpose of spreading the cement of brotherly love and affection...".

But why is the trowel the principal Working Tool of the Master Mason? I think it may have something to do with the progression of the construction of a building.

Entered Apprentices are taught the use of the twenty-four inch gauge and common gavel, two rudimentary tools used to create building blocks. Much like these working tools, the Entered Apprentice lectures are rudimentary as the new Brother progresses to become a building block of our Fraternity. It is very important that these building blocks be prepared correctly. A building is no better than its materials. If our lodges are to grow and get better our Entered Apprentices need to be shaped and formed. A lot of what he has to learn is foreign to him and it is important that our new Brother be properly mentored by someone with skill and dedication. We need to make sure he knows that he became a part of our Fraternity the moment he took his Obligation.

The Fellow Craft Degree teaches us to make use of the plumb, square and level. These tools are more advanced, just as the lessons in the Fellow Craft Degree are more advanced. As our new Brother takes his second step in Masonry he receives many beautiful lectures on true respect for Womanhood, the human senses, the Orders of Architecture and the liberal arts and sciences.




In the Master's degree the knowledge and lessons learned as Entered Apprentices and Fellow Crafts are extended even further. We receive the final lessons of the Blue Lodge degrees. We become the cement that unites the building blocks of Masonry into one common mass. That cement has shown up in many wonderful cases over the course of history. Many of the greatest examples have shown up during the terrible trials of war. I have read many stories of cases during the Revolutionary and Civil wars where one Mason has taken care of another even though they were on the opposing side, because they were Masonic Brothers. It isn't that these Masons did not do their duty. It is just that in times of the ferocity of the war going on around them they

showed humanity to men who were their Brothers. There is a story of a Masonic doctor working in a prisoner of war camp during the Civil War who realized that some of the prisoners he was caring for were Brother Masons. This doctor passed out all the money he had among them so that they might have a better chance of surviving the degradations of the POW camp. If you read stories of Masons during wartime you will find many on this subject and they will all touch you as they have me.

In a Fraternity made up of so many different individual building blocks it is only natural that from time to time there may be some contention among our members. However, we should remember that if solders fighting on opposing sides can exhibit fraternal Brotherhood during times of war, surely we can do the same in our Lodge Rooms. Remember the language in our Master Mason Lecture: "...With the Mystic Trowel, let us spread liberally the cement of brotherly love and affection."





All Lodges throughout the State should review their revenue stream from regular Lodge dues. This income from regular dues should

satisfy utility, insurance, secretary, Lodge bills and maintenance expenses; if not the Lodge should consider raising their Dues along with fund raisers. The income from your Perpetual Endowed Membership funds could be utilized for repair, replacement and community activities.

Visiting with many of you brethren this past year, there continues to be questions about the Perpetual Endowed Membership Fund. The PEM Fund financially, is in good condition. This Fund has a current Market Value (11/30/2015) of \$6,297,096.11 in Government Bonds invested with NAFA Capital Market. Even with the declining interest rates, these Funds are returning over 6% and close to 7%. Many Lodges are experiencing limited cash flow from dues income. The purchases of a Perpetual Membership by a member within your Lodges can reduce that dependency.

The question comes up, is this still a good investment? My answer is YES! You cannot earn this high of interest anywhere else and it is an investment in the future of your Lodge and you can never lose a member for non-payment of dues.

Beside the PEM Funds, your Grand Trustees oversee the budget for the General Fund, Building Endowment, Library & Museum, Deferred Compensation Plan and Pension Plan for our current and retired employees.

History of Masonic Lodges of Southwest Oklahoma

W John D. Church

his will include a short history of the Masonic Lodges of Jackson, Harmon, Greer, Kiowa, and Tillman Counties. The information was gathered through the Proceedings of the Most Worshipful Grand Lodges of Oklahoma, Indian Territory and the Oklahoma Territory. In February 1909, with the combination of the two Grand Lodges, and as a result of a committee from both the Indian and Oklahoma Territory Grand Lodges, it was agreed that the existing 60 Indian Territory Lodges keep their current number and the existing Oklahoma Territory Lodges be renumbered beginning with number 61 based on the date of granting their Dispensation.¹

Mangum Lodge # 61: Chartered: - originally Chartered as Mangum Lodge # 685² by the Grand Lodge of Texas as part of Greer County Texas. On May 4, 1896, the land was officially assigned by Congress to Oklahoma Territory and was chartered by Oklahoma Territory Grand Lodge as Mangum Lodge #29 on the first day of the Annual communication on April 16, 1896.³ When the Grand Lodges of Oklahoma Territory and The Indian Territory consolidated in 1909 Mangum was chartered as Mangum Lodge # 61. Mangum Lodge has had the privilege of being the home lodge of three Past Grand Masters. M W J. Frank Matthews P G M 1904 O. T. received his degrees in Mangum Lodge No. 29 (now No. 61) in 1896. He also served as a Judge in Greer and Jackson Counties. He was elected as a Representative and Senator from Greer county in 1904. M W Ray Keith Babb P G M 1959 served Mangum Lodge No. 61 as Master in 1934. He was also the President of the Certificate Lecturers Association in 1955. M W Ray K. Babb Jr. P G M 1989 received his degrees from Mangum Lodge No. 61. He also served as Worthy Grand Patron Oklahoma Eastern Star in 1994.

Altus lodge #62: Chartered 1891 U. D. -originally Chartered as Altus Lodge #711² by the Grand lodge of Texas as part of Greer County Texas. On May 4, 1896, the land was officially assigned by Congress to Oklahoma Territory and was chartered by Oklahoma Territory Grand Lodge as Altus Lodge #30 on the first day of the Annual communication on April 16, 1896.³ When the Grand Lodges of Oklahoma Territory and The Indian Territory consolidated in 1909 Altus was chartered as Altus Lodge #62. Altus Lodge is the home lodge of M W Bobby L. Laws P G M 1990. P G M Laws received his degrees from Union Lodge No. 28 in LaGrange Ga. in 1964. He affiliated with Altus Lodge No. 62 in 1975 while stationed at Altus AFB. He also served the Grand Lodge as Grand Secretary from 1992 -1993 and 2015 to present.

Cordell Lodge #127: Originally U.D. on February 4, 1898⁴ under the Grand Lodge of the Oklahoma Territory as Cordell Lodge #38. Changed to Cordell Lodge # 127, when the Grand Lodges of Oklahoma Territory and The Indian Territory joined together.


Sentinel Lodge #152: Originally U.D. on June 29, 1900⁵ under the Grand Lodge of the Oklahoma Territory as Wood Lodge #54. On October 18th 1902 the lodge was moved from the town of Wood to the Town of Barton due to the hall where their meeting took place was moved away.⁶ In the 1905 proceedings, it shows the lodge meeting in Sentinel but there is no record of the date the move was made.⁷ Changed to Sentinel Lodge # 152, when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Cordell Lodge # 127 on November 18, 1975

Granite Lodge #164: Originally U.D. on February. 17, 1901⁸ under the Grand Lodge of the Oklahoma Territory as Granite Lodge #63. Changed to Granite Lodge # 164, when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Altus Lodge #62 on August 11, 2009.

Mt. View Lodge #168: Originally U.D. on April 20,1901⁸ under the Grand Lodge of the Oklahoma Territory as Mt. View Lodge #65 - Changed to # 168 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. In 1904 Special Dispensation was granted to move the Charter from Mountain View in Washita County to Mountain View in Kiowa County, a distance of 1½ miles, which did not affect the jurisdiction of any other lodge. Mountain View was also the home of P G M Ernest Clyde Morris P G M 1960. Bro. Morris moved to Drumright Oklahoma in 1915 and took his Masonic degrees in Drumright Lodge in 1925.

Grand Lodge Rededicates Cornerstone on Oklahoma Capitol Building

It was a blustery but exciting day. On November 16, M W Smith and the Grand Lodge officers gathered at the invitation of the State officials to rededicate the cornerstone of the building originally laid with Masonic Ceremony in 1915.

It is interesting to read the account from the Proceedings of the time. (Photographs are from the 2015 ceremony. More are available on the Grand Lodge Site gloklahoma.com

(From the 1915 Proceedings)"The cornerstone for the new state house was laid according to program at Oklahoma City, Tuesday, November 16, by the Grand Lodge of Masons for the State of Oklahoma. The day was the eighth anniversary of the admission of the state into the union. Thousands of Masons and other citizens of the state witnessed the ceremony.

The ceremonies incident to the actual laying of the cornerstone were begun at 4 o'clock, when Governor Williams presented to Most Worshipful Grand Master E. A. Monroney, a small silver trowel, donated by the Stewart Construction company, builders of the capitol.

The massive native granite rock, bearing the Masonic emblem and the names of Governor Williams and Grand Master Monroney, was elevated by a steam crane to a height of about five feet from the place where it was to rest, at the southwest corner of

the west wing, while workmen covered the base with a thick layer of mortar. Silence was proclaimed by Past Grand Master Wm. P. Freeman, of McAlester, Grand Marshal, and the Masonic ceremonies began with the formal acceptance by Grand Master Monroney of the invitation of the state for the Masons to lay the stone.

Prayer was offered by W. W. Robinson, of Geary, Grand Chaplain. Using the silver trowel presented by the Governor, Grand Master Monroney went through the form of spreading mortar on the base where the stone was to rest. At the whistled signal the stone was

lowered one-third of the way while it was accorded the public grand honors in Masonry, the Masons clapping their hands three times, left over right. This was done three times until the stone was finally placed in its proper position.



After the block had been placed the different officers of the

organization tested it with level, square, and plumb line to make sure that it had been truly set. The same instruments, symbolic of those used in practical Masonry, are used in the exemplification of the teachings of the Masonic order.



Then followed the consecration of the stone, which consisted of sprinkling oil, wine and corn upon it. The corn, symbol of plenty, was placed on the stone by Deputy Grand Master Wier, of Hugo; the wine, emblem of joy and gladness, was poured by Senior Grand Warden Samuel W. Hogan, of Cashion; the oil, significant of peace, was poured by Grand Junior Warden Joseph W. Morris, of Snyder. This part of the ceremony closed with a prayer for the endurance of brotherly love and friendship.

With the striking of the stone three times with a gavel by Grand Master Monroney and an address by Woodson Norvell of Tulsa, Grand Orator, the ceremonies ended.

Grand Master Monroney remarked: "I desire at this time, on behalf of this M W Grand Lodge, to convey to our

Governor; Hon. Robt. L. Williams, his able Secretary A. N. Leecraft; Hon. Ed. S. Vaught and the members of the Capital Building Committee; Hon. Ed. Overholser, Mayor of Oklahoma City; and the citizenship of this great State and City, and to Harry Penticost; Wm. J. Pettee; Robert E. Flynn, director of the Military Band; C. R. Harkness, the director of the Masonic Band; Edward Vail Mcintyre and to everyone who so thoughtfully and kindly did all in their power to make this occasion a success—the sincere thanks and appreciation of the Masonic Fraternity for their very able assistance and co-operation."

Ruth Lodge # 172: Originally U.D. on May 22, 1901⁸ under the Grand Lodge of the Oklahoma Territory as Ruth Lodge # 67- Changed to # 172 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. The Proceedings of 1903 state that Ruth Lodge met at Corolea in Greer County whose Post Office was in Duke. The proceedings of 1910 still show the location of the lodge in Corolea. The proceedings of 1911 show the location as Duke but there is no reference as to the exact date the Charter was moved. Consolidated with Mangum Lodge # 61 on April 5, 1977.

Eldorado Lodge # 181: Originally U.D. on October 18,1901⁸ under the Grand Lodge of the Oklahoma Territory as Eldorado Lodge # 73 - Changed to # 181 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Yeldell Lodge # 196 on October 1, 2001.

Elk City Lodge #182: Originally U.D. on November 7, 1901⁸ under the Grand Lodge of the Oklahoma Territory as Elk City Lodge #74.- Changed to #182 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified.

Sayre Lodge #195: Originally U.D. on June 25, 1902¹⁰ under the Grand Lodge of the Oklahoma Territory as Sayre Lodge #83 - Changed to #195 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified.

Yeldell Lodge #196: Originally U.D. on July 15, 1902¹⁰ under the Grand Lodge of the Oklahoma Territory as Yeldell Lodge # 84 in Yeldell OK. - Permission was grant by the Grand Master to move the Charter to Elmer, OK November 6, 1909. Changed to # 196 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. J. Clay Thrash P G M 1968 began his Masonic career in Yeldell Lodge No. 196 in Elmer in 1948. He served as Worshipful Master of Yeldell Lodge in 1951. He also served as the President of the Certificate Lecturers Association in 1963.

Hobart Lodge # 198: Originally U.D. on August 8, 1902¹⁰ under the Grand Lodge of the Oklahoma Territory as Hobart Lodge # 85 - Changed to # 198 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified.

Foss Lodge # 204: Originally U.D. on October 21, 1902¹⁰ under the Grand Lodge of Oklahoma Territory as Foss Lodge # 86- Changed to # 204 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Cordell Lodge # 127 on September 12, 1977

Frederick Lodge # 249: Originally U.D. on February. 11, 1903¹¹ under the Grand Lodge of the Oklahoma Territory as Frederick Lodge # 92 - Changed to # 249 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified.

Snyder Lodge # 216: Originally U.D. on April 15, 1903¹² under the Grand Lodge of the Oklahoma Territory as Snyder Lodge # 96 - Changed to # 216 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Snyder Lodge consolidated with Frederick Lodge #249 on February 16, 1988. Joseph W. Morris P G M 1918 was made a Master Mason in Snyder Lodge in 1903 while it was still U.D.

Hollis Lodge # 219: Originally U.D. on May 7, 1903¹² under the Grand Lodge of the Oklahoma Territory as Hollis Lodge # 98 - Changed to # 219 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Altus Lodge #62 on Januaryuary. 17, 2009

Olustee Lodge #225: Originally U.D. on Jun 15, 1903¹² under the Grand Lodge of the Oklahoma Territory as Olustee Lodge # 101 - Changed to # 225 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Altus Lodge #62 on December 16,1986

Erick Lodge # 237 Originally U.D. on Sept 8, 1903¹² under the Grand Lodge of the Oklahoma Territory as Erick Lodge # 109 - Changed to # 237 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified.

Martha Lodge #278: Originally U.D. on January 20, 1905¹³ under the Grand Lodge of the Oklahoma Territory as Martha Lodge # 131 - Changed to # 278 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Altus Lodge #62 on June 20, 1957

Texola Lodge # 295: Originally U.D. on Jun 24, 1905¹⁴ under the Grand Lodge of the Oklahoma Territory Texola Lodge # 138 - Changed to # 295 when the Grand Lodges of Oklahoma Territory and The

Indian Territory unified. Charter Taken on January 8, 1958.

Gotebo Lodge #305: Originally U.D. on Sept 25, 1905¹⁴ under the Grand Lodge of the Oklahoma Territory as Gotebo Lodge # 143 - Changed to # 305 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Mt. View #168 on April 23 1973

Manitou Lodge #306: Originally U.D. on November 15,190514 under the Grand Lodge of the Oklahoma Territory as Manitou Lodge # 144 - Changed to # 306 when the Grand Lodges of Oklahoma

Territory and The Indian Territory unified. - No reports after 1917

Headrick Lodge #311: Originally U.D. on January 20, 190614 under the Grand Lodge of the Oklahoma Territory as Headrick Lodge # 148 - Changed to # 311 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Altus Lodge #62 on September 28, 2009

Davidson Lodge # 320: Originally U.D. on March26, 1906¹⁵ under the Grand Lodge of the Oklahoma Territory as Davidson Lodge # 154 - Changed to # 320 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Frederick Lodge #249 on December 6. 1966

Vinson Lodge # 325: Originally U.D. on April 11, 1906¹⁵ under the Grand Lodge of the Oklahoma Territory as Vinson Lodge # 158 - Changed to # 325 when the Grand Lodges of Oklahoma Territory and

The Indian Territory unified. - Consolidated with Mangum Lodge # 61 on Aug.21,1961

Blair Lodge #332: Originally U.D. on May 26, 1906¹⁵ under the Grand Lodge of the Oklahoma Territory as Blair Lodge # 159 - Changed to # 332 when the Grand Lodges of Oklahoma Territory and

The Indian Territory unified. - Consolidated with Altus Lodge #62 on February. 1, 1988

Clinton Lodge #161: Originally U.D. on August 26, 190615 under the Grand Lodge of the Oklahoma Territory as Clinton Lodge # 161 - Changed to #339 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. George H. Powers P G M 1978 received his degrees from Clinton Lodge No. 339 in 1947. He is a past Secretary and Treasurer of the Certificate Lecturers Association and served two terms on the Masonic Charity Foundation Board of Directors.

Delhi Lodge # 340: Originally U.D. on August 30, 1906¹⁵ under the Grand Lodge of the Oklahoma Territory as Delhi Lodge # 162 - Changed to # 340 when the Grand Lodges of Oklahoma Territory and

The Indian Territory unified. Consolidated with Erick Lodge # 237 on February 9, 1959.

Retrop Lodge #355: Originally U.D. on Jun 5, 1907 under the Grand Lodge of the Oklahoma Territory as Retrop Lodge # 170 - Changed to # 355 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Sentinel Lodge #152 on March 20, 1969. No record could be found of an entry in any Proceedings of a U.D. given to Retrop, however, in the 1908 Proceeding the Charters and Dispensations Committee recommends a Charter be issued to Retrop. 16

Lone Wolf Lodge # 371: Originally U.D. on April 18, 190817 under the Grand Lodge of the Oklahoma Territory as Lone Wolf Lodge # 176 - Changed to # 371 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. - Consolidated with Hobart Lodge #198 on April 25, 1983.

Rocky Lodge #373: Originally U.D. on April 28, 1908¹⁷ under the Grand Lodge of the Oklahoma Territory as Rocky Lodge # 181 - Changed to # 373 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified. Consolidated with Hobart Lodge #198 on December 13, 1937.

Grandfield Lodge #378: Originally U.D. on May 6, 1908 17 under the Grand Lodge of the Oklahoma Territory as Grandfield Lodge # 185 - Changed to # 378 when the Grand Lodges of Oklahoma Territory

and The Indian Territory unified.

Mountain Park Lodge # 383: Originally U.D. on Jun 9, 190817 under the Grand Lodge of the Oklahoma Territory as Mt. Park Lodge # 189 -Changed to # 383 when the Grand Lodges of Oklahoma Territory and The Indian Territory unified - Consolidated with Snyder Lodge #216 on November 16, 1971. As an interesting note; the proceedings of 1925 also show a dispensation for U.D. issued to Mountain Park on May 17, 1924. 18 No other references can be found to explain why a second U.D. was issued to the same town under the same lodge name. Gilbert Beebe Bristow P G M 1925 received his degrees from Mountain Park Lodge No. 168 in 1907. He served that Lodge as Worshipful Master in 1912, 1914, 1916, 1917, 1920, and 1921. He was also the first Worthy Patron of Roosevelt Chapter No. 340 Order of the Eastern Star. Continued on page 24

Mell Done, Brother Andrew!!



On December 11th Brother Andrew Schaeffer presented a remarkable concert on the pipe organ in the auditorium of the Guthrie Scottish Rite Temple. An Entered Apprentice at Oklahoma City Lodge 36 and Director of Music Ministries and Principal Organist at First United Methodist Church in Edmond, Brother Andrew is working on a Doctor of Musical Arts Degree in Organ Performance at O.U.

He has appeared as accompanist for the National Lutheran Choir, received the *Officium ad Ducere* [Leadership by Service] Alumnus of the Year award from Luther North College Prep, and was recently named one of the "top 20 under 30" young church musicians and organists by *The Diapason* magazine.

It was an outstanding concert. While most people think that the hardest part of organ playing is keeping track of the hands and feet with the different keyboards involved, one of the most challenging aspects is "registration," selecting which combination of the many voices or stops on the organ will



produce the sound desired. There are literally thousands of combinations possible on an organ the size of the one in the Scottish Rite Temple with pipes ranging from less than 4 inches in length to ones greater than 32 feet. Especially during the suite from the Nutcracker ballet, it was possible to close your eyes and truly hear all the instruments of a symphony orchestra.



The Temple's Kimball Organ is an "orchestral organ" which differs from a "church organ" or a "theatre organ" in that many of its stops are designed to imitate the sounds of such instruments as oboes, violas, and tubas—but that only truly works at the hands of a skilled performer.

In addition to some traditional carols and secular Christmas songs, with which the audience was encouraged to sing along, the concert included "In Dulci Jubilo" by Johann Sebastian Bach, "Variations sur un Noel" by Marcel Dupré, "Greensleeves" in the arrangement by Richard Purvis, and the aforementioned suite from "The Nutcracker."




Below is a 1905 Map of the Oklahoma and Indian Territories of Southwest Oklahoma where these Lodges were located. Also a 1915 map of Southwest Oklahoma after the establishment of Jackson and Harmon counties which were divided from Greer County, and Tillman county which was part of Comanche county.

As you can see from the maps, many of the communities in Southwest Oklahoma in the late 1800's and early 1900's had a Masonic Lodge. Throughout the older proceedings you find that many of the Lodges held their regular meetings, on Southwest Oklahoma in contract the full maps in each meeting.







Rite On!

THE SCOTTISH RITE has been an integral part of the Masonic Family in Oklahoma since 1896. Its foundational goal of offering more light in Masonry and adding to the Masonic education of Oklahoma Masons has proven to be a popular fraternal venue for men for well over a century.



As a testament to the Scottish Rite's significance in the area of Masonic education, it is noted that 44% of the Master Masons in Oklahoma also belong to the Scottish Rite.

Its popularity is driven in part by its beautiful Masonic buildings in Guthrie and McAlester, its commitment to childhood language disorders in children in Tulsa, its statewide venue of expanding Masonic friendships and contacts beyond the boundaries of the individual Oklahoma lodge, and the fact that the Scottish Rite is nationally known as being the college course in Freemasonry. The three Scottish Rite Valleys in Oklahoma have distinguished themselves for their long commitment to quality in their degree work.

All Master Masons who have fulfilled the proficiency requirements of the Blue Lodge, or have been Master Masons for more than six months, are eligible to join the Scottish Rite. The choice of belonging to Guthrie, Tulsa, or McAlester is up to the individual brother. Usually, men select the Valley which is the closest to their place of residence.

The dates for the 2016 Oklahoma Scottish Rite Reunions are shown here. The fee for joining is \$175 and the annual dues to the Rite are \$80.

If you want to continue your education in Masonry in 2016, or extend your fellowship with brothers beyond your own Lodge, a good place to start is to contact one of the Valley Secretaries (contact information above). For further information, you can also peruse the information on the three Scottish Rite websites.

Men joining the Fraternity today are looking for education. The Scottish Rite is a big help to our Lodges in fulfilling this interest. It has always been a big part of Oklahoma Masonry.

THE YORK RITE is the third leg which completes the great triangle of Masonic Bodies in Oklahoma, along with the Blue Lodge and Scottish Rite. Like the Scottish Rite, the York Rite is also Degree based and focused on offering Master Masons further education in Masonry. Although the Degrees of the York Rite largely originated in England, the Rite is often referred to as the American Rite since its Degrees and

Orders were organized and promulgated into a single system of work by the prominent 18th Century American ritualist, Thomas Smith Webb. The York Rite meets through local Chapters, Councils, and Commanderies which are chartered to operate in key Blue Lodges across Oklahoma.

Two of the several important Masonic traditions are particularly emphasized in the York Rite-the Royal Arch tradition, and the Knight Templar tradition. The Royal Arch tradition is concerned with discovering that which was lost in the Master Mason Degree; and the Knight Templar Tradition focuses on the values of Christian Knighthood.

It is generally held by men who have a special interest in Masonic history, legacy, education, symbolism, and philosophy that to belong to the three great Masonic Bodies inclusive of the Blue Lodge, the Scottish Rite, and the York Rite, is truly the cornerstone upon which improvement in Masonry can be fully attained.

The same joining rules apply to the York Rite as to the Scottish Rite. One must have demonstrated his proficiency in the Master Mason Degree, or been a member for not less than 6 months. The joining fee for the York Rite is set by the local Bodies. There are three venues for becoming a York Rite Mason in Oklahoma. One can petition a local York Rite Body and receive his Degrees from that Body. He can receive his Degrees at regional York Rite Festivals, held two times a year at various locations around the state. Or he can receive his Degrees at a statewide York Rite festival honoring the Grand Master of Masons in Oklahoma, which is held one day a year.

The First 100 Days

Have you ever heard of "The First 100 Days?" It is a term that has been used to measure the success of a President during the time when his influence is usually at its peak – the first 100 days after he takes the oath of office.

For example, FDR is often hailed as one of our most influential Presidents because during his first 100 days as President he pushed through 15 major bills that although controversial at the time, have persisted and are now considered some of the most important functions of government.

Presidents often get voted into office with a lot of campaign promises. We usually find out pretty quick if they are able to deliver on those promises. History has shown that if a President does not fulfill his campaign promises within the first 100 days of his office, those promises will probably go unfulfilled. There are many reasons for this. One is that pre-existing negative influences catch up with, and overcome, the positive influences which got him elected. The newly elected President must have the skill necessary to maintain the positive momentum that got him elected while at the same time keep the old negative influences at bay. He must keep his fresh, new programs and ideas from being overwhelmed by the negative, by the stagnant, by the old guard, by the "we've never done it that way before".

The same analogy can be applied to the Worshipful Master and his Lodge, but on a one-quarter scale. A President's term of office is 4 years, but the Master only gets one year. In other words, instead of 100 days, the Master only gets 25 days. That means his very first Stated Communication can determine if his goals will be accomplished during his year. If he waits until his first Stated Communication to get started, he is already outside his window of opportunity to try to stay one step ahead of the "we've never done it that way before."



We all know Brothers who first point to reasons why something cannot be done instead of first finding ways to make things happen. Names and faces may be coming into your mind right now. No names will be mentioned to protect the guilty but you know who I am talking about. Just like our Presidents, the challenge of the upcoming and new Worshipful Master is to keep moving forward to accomplish those positive things which are his goals for the year while at same time keep the negative people and negative issues at bay.

Every Senior Warden and upcoming Worshipful Master should carefully think about what he wants to accomplish during his year. It is never too early to make plans and set goals. How will his Lodge remember his year? Will his year create positive or negative memories?

What will his legacy be?
