**From the Senior Grand Warden

***The Level***



The level is an instrument made use of by the operative masons to make sure that their work would be level enough to survive the test of time; to make sure that their work remained true to its foundation as it rose to greater and greater heights. Webster's Dictionary defines the word level as "having no part higher than another, having a flat or even surface."

In Masonry, the level means that everyone should meet on the same level no matter what our status is in the world. It does not matter what we do for a living, who our relatives may be, or how much money we may have, in the lodge room we are all equal and should receive the same respect.

When I think of the level and how we are all equal in everything, I remember one of our Brothers in Shawnee. I will just refer to him as Brother Rex. He had many stories about World War II. He shared with me that he was one of the soldiers ready to invade Japan, but the military dropped the atomic bombs and the invasion was called off. He always said, "If it hadn't been for Harry Truman, I wouldn't be here today." One of his best stories was when he actually met President Truman in his home lodge. This would have been in the late 1940's, after the war was over. I don't remember what lodge Brother Rex was raised in, but he was raised a Master Mason in Missouri.

As I remember the story, the lodge had just opened, and there was an alarm. The Worshipful Master ordered the alarm attended, and when the Junior Deacon opened the door, there stood Harry Truman, President of the United States.

The Worshipful Master probably knew they were going to have a special visitor that night, but Brother Rex had no idea. He was in awe and didn't know what to do! He wondered if the lodge should stand up or just stay seated, as the President came in, went before the altar, and saluted the Worshipful Master. The Master welcomed him to the lodge and the President took a seat. Brother Rex stated that what surprised him the most was that he was by himself, although he learned later that his secret service agents were not Masons, so they remained outside the Tyler's door. It was a very interesting and delightful evening for Brother Rex.

One of the things that Brother Rex shared with me about that evening was the fact that even though Harry Truman was the President of the United States, he was Brother Truman when he came in the lodge room door. They didn't call him Mr. President; they called him Brother Truman, at his request. Brother Rex was able to tell Brother Truman thanks for doing what needed to be done, and that he knew Brother Truman had saved his life as well as the lives of so many others.

This story is a great example of the Level of Equality for Masons. My hope is that we will always meet on the level with all our Brethren and treat each other with the respect that good Masons should have for each other.

In closing I would like to remind you of these upcoming dates. I hope to see you there.

**From the Junior Grand Warden

Brethren:

I started attending Grand Lodge in 1980. It was the first time I had received credentials to vote as a delegate of my lodge. An old mentor of mine informed me it was an obligation of my office as a Warden. That was enough for me. Obligations were important. I had heard a dozen years earlier that these special duties are what make a man a Mason. If I couldn't honor my own obligations to my lodge, how could I expect any other Brother to do the same? As they say, it was a no brainer. It is what leaders in any organization do.

But my mentor was also an A Certificate Lecturer. He had taught me all of my work while going through the chairs. His approach was reasonable and admirable. He taught that if every officer would only learn the language of his office each year (including the degree work), he would not only serve his lodge well but, when he got to the East, there would be little left to learn. He was right. I became an A Certificate Lecturer the year after I served as Master of the Lodge because of his sage advice.

I introduce my own story to you to suggest to all elected Wardens and Masters not to overlook your duty to attend Grand Lodge this year. After all, it is your obligation to your lodge. It is the foundational reason Grand Lodges exist. They are an assembly of lodges. They do not exist without a majority of lodges seeing to it that their delegates participate.

And, in far too many instances, lodges are represented only by their Past Masters. This occurs only because those who are Wardens and Masters are not paying attention to their duties. Of course, we are grateful to our Past Masters for attending and making the annual communication of Grand Lodge possible, but these men are no longer elected lodge leaders. They do not have the same obligations required of leadership as the elected men in their lodge.

The annual communication held by Grand Lodges was originally intended to be a communication between elected lodge officers and elected Grand Lodge officers. It was a peerage of leadership. It is this group of men who are supposed to be the most concerned about the problems and issues of the fraternity; and the most observant and dedicated in devising means to create a path of progress and growth for their lodge. What better reason is there for any elected officer to exist than to be an agent for the progress and sustainability of his lodge?

It may well be that only when elected lodge officers and Grand Lodge officers met together regularly that the fraternity was focused more on its future than its past. Perhaps it is time to recreate this model of communication in our own Grand Jurisdiction.

So, if you are an elected officer, I urge you to attend our upcoming Grand Lodge session. Participate in the discussions, enjoy the fraternalism, get acquainted with your peers, talk about what is working or not working in your lodge, excite us with your successes, and tell us of your dreams for your lodge and Oklahoma Masonry!

And while you are in Guthrie, give yourself a treat and drop by Grand School for a day and bone up on the language of your office. It is a gift that will always serve your lodge.



### Resolution No. 1-A

**WHEREAS:** The Constitution and Laws requires a Tellers Committee to be appointed by the Grand Master, Deputy Grand Master, Senior Grand Warden and Junior Grand Warden to oversee the election and count ballots; and,

**WHEREAS:** A change to electronic voting in other jurisdictions has proven to be less time consuming and require fewer tellers; and,

**WHEREAS:** the results of the vote should be known in a matter of seconds; and,

**WHEREAS:** moving to electronic voting devices will permit delegate registration to stay open an additional one (1) hour, for the convenience of delegates traveling long distances; and,

**WHEREAS:** All voting, both for elected officers and resolutions, in the afternoon in the main auditorium.

**NOW THEREFORE BE IT RESOLVED:** that Section 201 Grand Officers which now reads in part:

Section 201 Grand Officers: The Grand Master, Deputy Grand Master, Grand Wardens, Grand Treasurer, Grand Secretary and Grand Lecturer shall be elected by paper ballot, without nominations, at each annual communication. They shall be installed before its close and shall hold their offices one (1) year or until their successors are elected and installed. A majority of all the votes cast shall be necessary to elect the officers mentioned herein.

#### BE AMENDED TO READ:

Section 201 Grand Officers: The Grand Master, Deputy Grand Master, Grand Wardens, Grand Treasurer, Grand Secretary and Grand Lecturer shall be elected by electronic voting device or paper ballot without nominations, at each annual communication. They shall be installed before its close and shall hold their offices one (1) year or until their successors are elected and installed. A majority of all the votes cast shall be necessary to elect the officers mentioned herein.

### Resolution No. 1-B

**WHEREAS:** The Constitution and Laws requires a Tellers Committee to be appointed by the Grand Master, Deputy Grand Master, Senior Grand Warden and Junior Grand Warden to oversee the election and count ballots; and,

**WHEREAS:** A change to electronic voting in other jurisdictions has proven to be less time consuming and require fewer tellers; and,

**WHEREAS:** the results of the vote should be known in a matter of seconds; and,

**WHEREAS:** moving to electronic voting devices will permit delegate registration to stay open an additional one (1) hour, for the convenience of delegates traveling long distances; and,

**WHEREAS:** All voting, both for elected officers and resolutions, in the afternoon in the main auditorium.

**NOW THEREFORE BE IT RESOLVED:** SECTION 302 REGISTRATION OF DELEGATES AND BALLOTS, which now reads:

#### SECTION 302. REGISTRATION OF DELEGATES AND BALLOTS:

A delegate to the annual communication of the Grand Lodge shall register his credentials with the Credentials Committee, at which time he shall receive a badge which shall be so distinguished as to indicate the number of votes he is entitled to cast. The Credentials Committee shall carefully make a record of the number of votes registered. No member shall be entitled to vote until his name has been registered with the Credentials Committee.

When voting by ballot each lodge shall be entitled to three (3) votes through its representatives present in Grand Lodge. Other delegates to Grand Lodge present at the time of balloting are each entitled to one (1) vote. If a delegate, by reason of his past rank, is entitled to a vote and is also representing his lodge with proper credentials, he may vote in each capacity.

The election ballots issued at the annual communication shall be imprinted with the date of that communication and the names of the candidates for each office. All voted ballots shall be carefully preserved and placed in the vault in the Grand Secretary's office and be kept there for a period of one (1) year. The ballots may be reviewed by any member of the Grand Lodge of Oklahoma when accompanied by an elected Grand Lodge Officer.

**BE AMENDED TO READ:**

#### SECTION 302. REGISTRATION OF DELEGATES AND BALLOTS:

A delegate to the annual communication of the Grand Lodge shall register his credentials with the Credentials Committee, at which time he shall receive a badge which shall be so distinguished as to indicate the number of votes he is entitled to cast. The Credentials Committee shall carefully make a record of the number of votes registered. No member shall be entitled to vote until his name has been registered with the Credentials Committee.

## To be Considered During the Annual Communication

### Resolution No. 1-B Continued

When voting by electronic device or paper ballot each lodge shall be entitled to three (3) votes through its representatives present in Grand Lodge. Other delegates to Grand Lodge present at the time of balloting are each entitled to one (1) vote. If a delegate, by reason of his past rank, is entitled to a vote and is also representing his lodge with proper credentials, he may vote in each capacity.

The election ballots issued at the annual communication shall be imprinted with the date of that communication and the names of the candidates for each office shall be projected on a display screen. All printed reports of the electronic voting results or voted paper ballots shall be carefully preserved and placed in the vault in the Grand Secretary's office and be kept there for a period of one (1) year. The printed reports of the electronic voting or paper ballots may be reviewed by any member of the Grand Lodge of Oklahoma when accompanied by an elected Grand Lodge Officer.

# Resolutions

## To be Considered During the Annual Communication

### Resolution No. 1-C

**WHEREAS:** The Constitution and Laws requires a Tellers Committee to be appointed by the Grand Master, Deputy Grand Master, Senior Grand Warden and Junior Grand Warden to oversee the election and count ballots; and,

**WHEREAS:** A change to electronic voting in other jurisdictions has proven to be less time consuming and require fewer tellers; and,

**WHEREAS:** the results of the vote should be known in a matter of seconds; and,

**WHEREAS:** moving to electronic voting devices will permit delegate registration to stay open an additional one (1) hour, for the convenience of delegates traveling long distances; and,

**WHEREAS:** All voting, both for elected officers and resolutions, in the afternoon in the main auditorium.

**NOW THEREFORE BE IT RESOLVED:** SECTION 304, Balloting and Voting, A and B, which now reads:

**SECTION 304. BALLOTING AND VOTING:** The Grand Master, Deputy Grand Master, Senior Grand Warden, and Junior Grand Warden shall appoint an equal number of tellers to manage the election and resolution balloting process. The Grand Master shall also appoint a chairman of the tellers. It shall be the duty of the tellers to ensure that no campaigning occurs within or in close proximity to the election balloting area; to receive, count, and report the results of all balloting; and to see that the provisions of this section are obeyed.

**A. ELECTION OF OFFICERS:** On Saturday of the annual communication of the Grand Lodge, an area shall be designated for delegates to ballot on the candidates for elected offices. All names for the unfilled office shall be dropped except the two (2) having the highest number of votes on the first ballot. All other names on the second and subsequent ballots shall be declared mutilated and shall not be counted.

**WHEREAS;** a resolution passed by the Oklahoma Craft in 2013 increased the per capita by the amount of \$2.00 (two dollars), all of which must be placed in the Grand Lodge Building Endowment Fund, and only 5% (five percent) of the principle of this fund may be used for maintenance or capital improvements of the Grand Lodge facility; this \$2.00 (two dollars) is not paid by perpetual members before 2015; and;

**WHEREAS;** the last per capita increase to the General Fund was in 1998 (twenty years ago, when our membership was approximately 38,000 members), and increased from \$6.00 (six dollars) to \$8.00 (eight dollars) per member; and;

**WHEREAS;** the Grand Lodge is limited to use only an average of 95% (ninety-five percent) of the total revenue in the Grand Lodge budget, which continues to decrease each year; and;

**WHEREAS;** the Grand Lodge Trustees have done, and continue to do, everything in their power (including paying their own expenses) to provide the required services to the lodges, and, have, in effect, had to resort to fundraisers to assist in the day-to-day operations; and;

**WHEREAS;** there are 21,254 (twenty-one thousand two hundred fifty-four) Master Masons in Oklahoma, as of June 25, 2018; of which 9,789 (nine thousand seven hundred eighty-nine) are perpetual members whose per capita is set and cannot be changed, leaving 11,465 (eleven thousand four hundred sixty-five) dues-paying members; and;

**WHEREAS;** to keep pace with today's economy and provide the lodges with the services they require, we must increase our per capita.

**NOW THEREFORE BE IT RESOLVED,** that Section 502 paragraph A of the Constitution and Laws, which currently reads:

A. Per Capita for each Master Mason on the roll January 1:  
1:.....\$10.  
Unless superseded by section U 420 D.4 and D.5.  
\$2.00 of the above figure shall be permanently endowed and placed in a Grand Lodge Office Facilities Endowment Fund. The total amount of income derived annually from said fund, not to exceed 5% of the corpus, shall be used for maintenance or capital improvements in an owned office building or lease payments in a leased office facility.

A. Per Capita for each Master Mason on the roll January 1,  
2020.....\$10. **\$15.00**  
Per Capita for each Master Mason on the roll January 1,  
2021..... **\$20.00**
